4) Minimum avg. annual construction turnover of TK 1200.00 (One Thousand Two Hundred) Lac supported by payment certificates for works during last Five years.

5) Minimum Liquid assets/credit facility of Tk. 200.00 (Two Hundred) Lac. Adequacy of minimum liquid assets substantiated by any scheduled Bank of Bangladesh as specified in the format (attached with tender document), without any alteration, issued not earlier than twenty eight days prior to the day of the original deadline for submission of Tender.
