Eligibility of Tenderer : This invitation for Tender is open for all eligible Tenders as mentioned below:

(a) The minimum number of years of general experience of the Tenderer in Construction Works as Prime Contractor shall be 5 years.

(b) The minimum specific experience as a Prime Contractor of at least 1 (one) Building Construction with pre-cast pile foundation under single contract completed within the last 5(Five) years of a value of at least Tk 225 (Two HundredTwenty Five) Lac in Government/ Semi-Government/ Autonomous Organization of Bangladesh.

(c) The required average annual construction turnover shall be greater than Tk 365 (Three Hundred Sixty Five) Lac over the last 5(Five) years in Government/Semi-Government/ Autonomous Organization of Bangladesh. A summary sheet of last five years Turnover to submitted with all supporting documents.

(d) The minimum amount of free fund (liquid assets) i.e working capitals or credit facilities of the Tenderer shall be Tk 65 (Sixty Five) Lac. Document of Liquid Assets to be submitted along with the tender must be issued in between publication date and submission date of the tender. Certificate of unconditional Liquid Asset must be in the form of letter of commitment of Bank for line of credit to the Tenderer in favour of the work in PW3-7 form, otherwise the tender will be summarily rejected.

(e) The Tenderer must have up-to-date ABC License and Electric Supervisory License of his own from Electric Licensing Board.

(f) The Tenderer must have up-to-date Trade License, VAT Registration Certificate, up-to-date Income Tax Clearance Certificate

(g) Minimum Tender Capacity shall be Tk 245 Lac. The Tenderer must submit Tender Capacity Calculation sheet with supporting documents of i) Maximum value of Works performed in any one year during last five years and ii) Value of Existing commitments and works to be completed during the next 17 months.
