**Eligibility of Tenderer :** 1. Reputed Contractors/Construction firms who have minimum **5 (five) years**

- of general experience in construction works.
2. Having experience as a Prime Contractor or Subcontractor or Management Contractor in Successful completion of at least 1 (One) No. Repair/Maintenance or RCC Building construction work of **Tk. 25.00 (Twenty Five) lac** in a single contract in Government/ Semi-Government/ Autonomous Organization of Bangladesh during last 5(five) years. In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer. In case of the work done under any Government/ Semi-Government/ Autonomous Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done.
  3. The tenderers shall have a minimum average annual construction turnover during last 5 (five) years of **Tk. 80.00 (Eighty) lac**. Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.
  4. The minimum amount of liquid asset or works capital or credit facilities of the tenderer shall be of **Tk. 25.00 (Twenty Five) lac**. Letter of Commitment for Bank's Undertaking for Line of Credit as per forms available in Tender and Contract Forms section of tender document must be submitted for this purpose.
  5. The minimum Tender Capacity shall be **32 (Thirty Two) Lac BDT**.
  6. Tenders having quoted the offer in percentage is more than 10 (Ten) percent above or below the official cost estimated of the proposed works, shall be rejected.
  7. All other qualification criteria will be as per TDS and ITT included in this tender.
