- (c). If the Tenderer submit any false, incorrect or forged certificate, the tender security may be forfeited (If applicable).
- (d). The original money receipt of purchasing tender document, attested copy of TIN & VAT registration certificate, bank solvency certificate & other certificates mentioned In clause-22 must be submitted with the Tender.
- (e). For any unavoidable reason if the office remain closed at the date of last selling, receiving & opening, the tender will be sold, received and opened in the next office day at the same time.
- (f). The tender evaluation committee will review all the eligible tenders & retain only the responsive tender. Tender will be evaluated as par PPR-2008.
- (g). Tender price (Bid price) must include all duties, taxes and other levis in force during the entire contract period.


