	(c)	The Tenderers shall have a minimum average annual construction turn over during last 5(five) years of Tk. 175.00 (One hundred Seventy five) Lac .			
	(d)	The tenderer must have a minimum liquid assets/credit facilities net of other contractual commitments of the successful Tenderer shall not be less than Tk. 30.00 (Thirty) Lac (In this purpose Bank statement is required for a period with in 28 days before the date of submission of tender).
