22.	Eligibility of Tenderer :	This invitations of tenders is open to all eligible tenderer or JVCA as mentioned below:	
	a) Reputed Contractors/Construction firm who have minimum 05(Five) years of general experience in construction works.		
	b) Experience in successfully completion of at least 1(One) number of similar nature works with Pile foundation including sanitary & Electrical works of amounting to minimum Tk 230.00 (Two hundred Thirty) Lac in a single work order in Government semi-Government/Autonomous Organization during last 5(Five) years as stated in TDS of Tender documents. In case of JVCA the percentage of partner must satisfy the state above Tk 230.00 (Two hundred Thirty) Lac in single work experience that must be state in certificate.		
	c) (i) In case of a work done under PWD the Certifying and authenticating authority shall be the concerned Executive Engineer under whom the work has been executed.		
	ii) In case of work done under any Government / semi-Government / Autonomous Bodies/Government Organization other than PWD the certifying authority shall be an officer of the organization (Not below the rank of Executive Engineer) and duly verified by the concerned Executive Engineer of PWD of that District / Area within whose territory the work lying as per format for this purpose provided with the tender document.		
	d) The Tenderer must have a minimum average annual construction Turnover during the last 5(Five) years shall be Tk 485.00 (Four hundred Eighty Five) Lac Only against which certificate from NBR / DC, Tax should be Preferred.		
	e) The Tenderer must have a minimum amount of free funds (liquid Assets) or Credit facilities against the work shall be Tk 81.00 (Eighty One) Lac Only as stated in Tender Data sheet of Tender document. (Bank Certificate / Transaction statement in this regard should be issued not more than 28(Twenty Eight) days before the date of submission of the Tender.		
	f) The tenderer must enclose with the tender valid VAT registration certificate and up to date Income tax certificate from the NBR.		
	g) Tenderer must enclose up to date Trade License with the Tender.		
	h) Original Money Receipt must be enclosed with the Tender.		



i) The Tenderer must have up to date Electrical **ABC** and supervisory license from Electricity Licensing Board, Govt. of Bangladesh.

j) All other eligibility and conditions as mentioned in tender documents must be fulfilled and submitted.

K) Special instruction:

i) All documents submitted must be signed by the Tenderer in each page. All true copies/Photocopies documents submitted must be attested as per prevailing laws / rules.

ii) In case of JVCA to qualify each of its partners must meet at least 25% (twenty five percent) of minimum criteria of individual tender and lead partner at least 40% (forty percent) of those minimum criteria for construction Turn-over and amount Liquid assets. Failure to comply with these requirement will result in refection of the JVCA Tender.

iii) This tender notice in brief and the details of the tender can be seen from the office of the undersigned during office hours.

iv) The tenderer himself of his / their authorized representative may remain present at he time of opening of the tender.

v) If is not possible to receive / open the tender on the schedule date for any unavoidable circumstances, the same will be received / opened on the next working date at same time & same venue.

vi) If the tenderer submits any false / incorrect or forged certificate, the tender security may be forfeited.
