 - ii) The minimum specific experience as a Contractor in construction works of at least 1(one) contract of similar nature building construction work successfully completed in Government / Semi-Government / Autonomous organization of Bangladesh within the last 05(five) years, with a value of at least Tk. 200.00 (Two Hundred) Lakh
 - iii) The required average annual construction turnover shall be greater than Tk. 450.00 (Four Hundred and Fifty) Lakh in the last 5 (Five) years.
 - iv) The minimum amount of liquid asset i.e working capital or credit line(s) of the Tenderers shall be Tk 80.00 (Eighty) Lakh (adequacy of minimum liquid assets i.e working capital substantiated by any scheduled Bank of Bangladesh in the format as specified Form PW 3-7 (CPTU STD PW3) (Failing to submit in PW 3-7 will make the tender non-responsive).
 - v) The minimum Tender capacity shall be: Tk 240.00 (Two Hundred and Forty) Lakh
 - vi) Tenderers having quoted the tender price more than 10% (Ten) percent above or below the official cost estimate, the tender will be rejected.
