 - ii) The minimum specific experience as a Prime Contractor in similar nature works in Government / Semi-Government / Autonomous organization of Bangladesh within the last 5 (Five) years, with a value of at least Tk. 450.00 (Four Hundred Fifty) Lacs in a single tender.
 - iii) The required average annual construction turnover shall be greater than Tk.1000.00 (One Thousand) Lacs in the last 5 (Five) years.
 - iv) The minimum amount of liquid asset i.e working capital or credit line(s) of the Tenderers shall be Tk 250.00 (Two Hundred Fifty) Lacs (Must be submitted in the Form PW3-7 from any scheduled bank, otherwise tender will be considered as non responsive)
 - v) The minimum Tender capacity shall be: Tk 550.00 (Five Hundred Fifty) Lacs.
 - vi) Tenderers having quoted the tender price more than 10% (Ten) percent above or below the official cost estimate, the tender will be rejected.
 - vii) Tenderers shall submit with its tender the following additional documents:
