This Invitation for Tender is open to all eligible Tenderers as mentioned below.

(a) General experience: Reputed Contactors/ Construction firms having general experience in construction works for minimum 05 (Five) years.

(b) Work experience: Must have successful completion of at least 1(one) number similar building construction work in Bangladesh under Government/semi Government /Autonomous Organization during last 05 (Five) years for minimum Tk. 24 (Twenty four) Lakh in a single tender. Last 05 (Five) years will be counted backward from the date of publication of IFT . In case of the work done under PWD, the certifying and out hunting authority shall be the concerned Executive Engineer.In case of the work done under any Govt./semi Govt./autonomous bodies other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same certificate will be duly verified by the concerned Executive Engineer of PWD of the District under whose jurisdiction of the work has been done in the format as attached with the tender document.

(c) The Tenderers shall have a minimum average annual construction turn over during last 05 (Five) years for TK. 33 (Thirty Three) Lakh.

(d) The minimum amount of unconditional free funds (liquid assets/ cash flow capacity/ credit facilities) Tk. 22 (Twenty two) Lakh.

(e) Tenderer must have valid Trade license, Up to date TIN certificate, Income Tax certificate, VAT Registration & ABC category Electrical license from Bangladesh Electric Licensing Board.

Other required eligibility and conditions of the tenderer are given in Tender Documents.
