

(c) The work certificate for successful completion of a work shall have to be issued by the officer not below the rank of Executive Engineer of concerned Department / Organization duly verified by the concerned Executive Engineer of PWD of the District/Area under whose jurisdiction the work has been done as per format ( Form-6) for this purpose provided with the tender document. (d) The tenderer must have a minimum average Annual construction Turn over during last 05 (Five) years shall be TK.250.00 (Two hundred fifty) lacs, i.e the total certified payments received for contracts in progress or completed under public sector for a period of last 5 years from the date of (IFT) which may supported by payment certificates or by audit reports audited by reputed Audit Firm or by NBR certificates for construction part only. (e) The minimum amount of liquid assets or working capital or credit facilities of the tenderer shall be TK.100.00(One hundred) lacs only supported by Unconditional Bank certificate (Original copy) only, mentioning the name of work and shall be in prescribed format attached with this tender provided by any scheduled Bank of Bangladesh. Bank statement period will be counted 28(Twenty eight) days before submission of tender.
