(c) The required average annual construction turnover shall be greater than Tk.8.30 crore in the last 5 years. (d) The minimum amount of liquid asset or working capital or credit facilities of the tenderer shall be of Tk.2.00 crore . If tenderer submit liquid asset document,he must be declared a statement overthrough bank that tenderer will expends that liquid asset for the execution of that particuler work (Name of the work). Document submitted along with the tender must be issued in between publication date and submission date of the tender in e-GP. (e) The minimum Tender capacity shall be: Tk 10.00 crore. (f) Tenderers may participate in the Tender as JVCA. Maximum number of partners in the JV shall not be more than 3. (g)Tenderers having quoted the tender price more than 10 percent above or below the official cost estimate, the tender will be rejected.
