- (a) The minimum number of years of general experience of the Tenderer in Construction Works as Prime Contractor shall be 5 years.
- (b) The minimum specific experience as a Prime Contractor of at least 1 (one) RCC Building Construction under single contract completed within the last 5(Five) years of a value of at least Tk 21.00 (Twenty One) Lac in Government/Semi- Government/ Autonomous Organization of Bangladesh.
- (c) The required average annual construction turnover shall be greater than Tk. 50.00 (Fifty) Lac over the last 5(Five) years in Government/Semi-Government/ Autonomous Organization of Bangladesh. A summary sheet of last five years Turnover to be submitted with all supporting documents.
- (d) The minimum amount of free fund (liquid assets) i.e working capitals or credit facilities of the Tenderer shall be Tk. 30.00 (Thirty) Lac. Document of Liquid Assets to be submitted along with the tender must be issued in between publication date and submission date of the tender. Certificate of unconditional Liquid Asset must be in the form of letter of commitment of Bank for line of credit to the Tenderer in favour of the work in PW3-7 form, otherwise the tender will be summarily rejected.
- (e) The Tenderer must have up-to-date Trade License, VAT Registration Certificate, up-to-date Income Tax Clearance Certificate.
- (f) Minimum Tender Capacity shall be Tk. 22.00(Twenty Two) Lac. The Tenderer must submit Tender Capacity Calculation sheet.
- (g) Graveyard of Muslim, Hindu, Buddhist and Christian have to be done with same cost but few architectural differences.
