2. The minimum Specific Experience as a Prime Contractor of at least 1 Building/ Similar Construction work under single contract completed within last 5 years of a value of at least Tk 400(Four Hundred)Lac in a single tender in Government/ Semi-Government/ Autonomous Organization of Bangladesh
3. In case of the work done under other departments except PWD, the Authenticating Authority shall be the concerned Executive Engineer of PWD.
4. The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk.210 (Two hundred Ten) lac. Document submitted along with tender must be issued in between publication date and submission date of the tender.
5. The tenderer shall have minimum average annual construction Turnover of Tk. 1075(One thousand Seventy Five)Lac during the last 5 years preceding the date of invitation of tender. Only payment certificated will be counted for turnover calculation. No completion certificate will be treated as payment certificate. The Tenderer must submit a summarized Turnover Calculation sheet of last 5 years, years counting backward from the date of publication of IFT in the newspaper
6. The minimum Tender Capacity shall be Tk. 425(Four Hundred Twenty Five)Lac. The Tenderer must submit Tender Capacity Calculation sheet with following supporting documents i) Maximum value of Works performed in any 1 year during last 5 years and ii) Value of Existing commitments and works to be completed during the next 12 months.
7. The Tenderer must have Up to date ABC Category Contractor & Supervisory License from the Electric Licensing Board of Bangladesh Government
8. The Tenderer must enclose up-to-date Trade license, Income Tax clearance certificate, valid VAT registration certificate, along with the Tender.
