

For this reason, Contractors should have at least 35,000 sft of shuttering materials to be used in different levels at a time as well as necessary scaffolding, hoist, concrete batching plant, concrete pumping machine, modern construction and survey equipments, required numbers of skilled manpower and should also have the ability to work day and night.</b>					
ii) <b>Contractors have to submit approach and methodology of works, works program in bar chart and network diagram of the principal activities including critical path method, schedule of key management and technical personnel, list of the equipments proposed for this project and other necessary documents mentioned in Tender Data Sheet (TDS), Particular Condition of Contract (PCC).</b>
