Eligibility of Tenderer : This invitation for Tenders is open to all e-GP system registered eligible Tenderers as mentioned below :

- a) Reputed Contractors/ Construction firms who have minimum 5 (Five) years of general experience in construction works.
- b) Having experience as a Prime Contractor or Subcontractor or Management Contractor in successful completion of at least 1 (One) number of RCC building

construction work of Tk. 40 (Forty) lacs in a single contract in Government/ Semi-Government/ Autonomous Organization of Bangladesh during last 5 (Five) years. In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer.

c) The tenderers shall have a minimum average annual construction turnover during last 5 (five) financial years of Tk. 100 (Hundred) lac. Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.

d) The minimum amount of liquid asset or working capital or credit facilities of the tenderer shall be Tk. 30.00 (Thirty) lacs.

e) The tenderer must posses ;

i) Up-to-date income tax clearance certificate.

ii) Valid VAT registration certificate.

iii) Up-to-date trade license.

v) Attested copy of documents mentioned in sl. No. i, ii, iii & iv are to be submitted.

vi) Tenderers having quoted the tender price more than 10 (Ten) percent above or below the official cost estimate, the tender will be rejected.
