Self work will not be entertained for the work experience. c) The Tenderer shall have a minimum average annual construction turnover during last 5 (five) years amounting of Tk. 1250 (One thousand two hundred fifty) lac only. d) The minimum amount of liquid assets or working capital or credit facilities net of other contractual commitments of the successful tenderer shall be Tk. 300 (Three hundred) lac only, supported by Bank certificate (Original copy only). Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender. e) In case of JVC/JVCA (Tk. 300/- Non-Judicial stamp) original deed should be enclosed with tender. f) Up-to date Trade license, income Tax clearance and VAT Registration certificate. g) Up-to date ABC category contractor & supervisory license issued form Electrical Licensing Board, Government of Bangladesh. h) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled. i) All other terms and conditions as per Tender document. | | |
