(B) Having experience in successfully completion/execution of at least 1(one) number of Electrical works worth not less than Tk. 9.00 (Nine) Lakh in a single work order/tender in Government/ Semi Government/Autonomous Organization of Bangladesh during last 5(five) years in standard work completion format attached in STD.
(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 30.00 (Thirty) Lakh.
(D) The minimum amount of Liquid Assets i.e. working capital/creditline of the tenderer shall be Tk. 15.00 (Fifteen) Lakh only, supported by Bank certificate against the name of the work in the form of PW2a-3 (Line of Credit) only. Bank certificate should be counted 28 (Twenty Eight) days before from the date of opening of tender. Otherwise tenderer will be treated as non-responsive.

(F) Up to date ABC/BC category contractory and supervisory license, issuing from Electrical Licensing Board, GoB.
