(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 70.00 (Seventy) Lakh. (D) The minimum amount of Liquid Assets i.e. working capital/credittline of the tenderer shall be Tk. 10.00 (Ten) Lakh only, supported by Bank certificate against the name of the work in the form of PW2a-3 (Line of Credit) only. Bank certificate should be counted 28 (Twenty Eight) days before from the date of opening of tender. Otherwise tenderer will be treated as non-responsive. (E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate (G) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.
