Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.

4. The minimum amount of liquid asset or working capital or credit facilities as PW3-7 format of the tenderer shall be Tk. 13.80 (Thirteen point eight zero) crore. Document submitted along with the tender must be issued in between tender publication and submission date

5. The minimum tender capacity shall be Tk. 13.00 (Thirteen) crore. In case of JV, tender capacity required for leading and other partner shall be as described in Tender Data Sheet (TDS). To calculate minimum tender capacity the tenderer must be submitted list of contract agreement, up to date payment certificate for on-going and completed contract under any public sector for the year in which maximum value of works performed within 5 years. In case of JV, Agreement between leading and other partner shall be required.
