(A) Reputed Government approved contractors/construction firms who have minimum 05(Five) years of general experience in Construction works.

(B) Having experience in successfully completion/execution of at least 1(one) number of similar nature of works worth not less than Tk. 13.00 (Thirteen) Lakh in a single work order/tender in Government/ Semi Government/Autonomous Organization of Bangladesh during last 5(five) years in standard work completion format attached in STD.

(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 12.00 (Twelve) Lakh.

(D) The minimum amount of Liquid Assets i.e. working capital/creditline of the tenderer shall be Tk. 10.00 (Ten) Lakh only, supported by Bank certificate against the name of the work in the form of PW2a-3 (Line of Credit) only, counted 28 (Twenty Eight) days before from the date of opening of tender.

(E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate

(F) Up-to dated ABC/BC category contractory& Supervisory License issued from Electrical Licensing Board, GoB.

(G) Having sufficient equipment and manpower to commence the works throughout the time.

(H) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.

(I) As per latest Amendment of PPR-2008 and ITT clause no. 30.3, Tenderers having quoted the tender price more than 10 (Ten) percent above or below the official cost estimate, the tender will be rejected.

(J) In case of tie for the evaluated price, the lowest evaluated tenderer shall be selected based on Past Performance Evaluation and rating matrix for different aspects mentioned in ITT clause no.30.4.
