(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 30.00 (Thirty) Lakh.

(D) The minimum amount of Liquid Assets i.e. working capital/creditline of the tenderer shall be Tk. 06.00 (Six) Lakh only, supported by Bank certificate against the name of the work in the form of PW2a-3 (Line of Credit) only. Bank certificate should be counted 28 (Twenty Eight) days before from the date of opening of tender. Otherwise tenderer will be treated as non-responsive.
