(c) The required average annual construction turnover shall be greater than Tk 360.00 Lac over the last 5(Five) years in Government/Semi-Government/ Autonomous Organization of Bangladesh supported by payment certificates. (d) The minimum amount of free fund (liquid assets) i.e working capitals or credit facilities of the Tenderer shall be Tk 120.00 Lac. Document of Liquid Assets submitted along with the tender must be issued in between publication date and submission date of the tender. Certificate of unconditional Liquid Asset must be in the form of letter of commitment of Bank for line of credit to the Tenderer in favour of the work in the form PW2-a, otherwise the tender will be summarily rejected.(e) The Tenderer must have up-to-date Income Tax Clearance Certificate, Trade licence and VAT Registration Certificate.(f) The minimum Tender Capacity of the Tenderer will be Tk.85.00 lac (g) The Tenderer must have up-to-date ABC Electric License and Electric Supervisory License of his own.
