Eligibility of Tenderer	This invitation for Tender is open to all eligible Tenderers as mentioned below : <b>a)</b> The intending tenderers must enclosed attested copy of <b>VAT Registration certificate, up-to-date Income Tax clearance certificate, up-to-date Trade License, up-to-date ABC/BC &amp; Supervisory license and original copy of money receipt.</b> <b>b)</b> Reputed Contractors /Construction firms who have min. <b>5(Five) years of general experience</b> of works and also having experience in successful completion of at least 1(one) number of building construction work amounting of <b>Tk. 250 (Two hundred Fifty) Lac within last 5(Five) years in a single tender</b> in Govt./Semi-Govt./Autonomous Organization of Bangladesh. i) In case of work done under PWD, the certifying & authentication authority shall be the concerned Executive Engineer, ii) In case of the work done under any Government / Semi-Government/ Autonomous Bodies/ Originations other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done. <b>c)</b> The tenderer must have a minimum <b>liquid assets /cash flow capacity/ working capital/ Credit facilities (Must be unconditional and provided in form of letter of commitment of Banks undertaking for line of credit (Form PW3-7) in Original form) of Tk. 60 (Sixty) Lac.</b> Certificate must be within 28 days up to the date of receiving of tender.
