For works done under any Govt./Semi Govt./Autonomous Body other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD under whose jurisdiction the work has been done.

5) Minimum amount of liquid assets/credit facilities of the Tenderer shall be Tk. 50.0 (Fifty) Lac. Adequacy of minimum liquid assets substantiated by any scheduled Bank of Bangladesh as specified in the format (attached with tender document), without any alteration, issued not earlier than twenty eight days prior to the day of the original deadline for submission of Tender.
