(i) In case of the work done under any PWD Division the certifying and authenticating authority shall be the concerned Executive Engineer under whom the work has been executed. (ii) In case of work done under any Government/Semi Government/ Autonomous Organization of Bangladesh other than PWD the certifying & authenticating authority shall be an officer of the organization not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD of that District under whose jurisdiction the work has been done. C). The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 100.00 (One Hundred) Lac . D). The minimum amount of Liquid Assets or working capital or credit facilities of the tenderer shall be TK. 45.00(Fourty Five) Lac only, supported by Bank certificate (Original copy only). Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.
