(B) Having experience in successfully completion/execution of at least 1(one) number of similar nature of civil construction work worth not less than Tk. 32.00 (Thirty Two) Lac in a single work order in Government/Semi Government/Autonomous Organization of Bangladesh during last 5(five) years.

(i) In case of the work done under any PWD Division the certifying and authenticating authority shall be the concerned Executive Engineer under whom the work has been executed.

(ii) In case of work done under any Government/Semi Government/ Autonomous Organization of Bangladesh other than PWD the certifying & authenticating authority shall be an officer of the organization not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD of that District under whose jurisdiction the work has been done.

(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 60.00 (Sixty) Lac.

(D) The minimum amount of Liquid Assets or working capital or credit facilities of the tenderer shall be TK. 50.00 (Fifty) Lac only, supported by Bank certificate (Original copy only). Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.

(E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate

(G) JVC/JVCA not allowed according to STD PW-2a.

(H) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.
