(c) The required average annual construction turnover shall be greater than Tk 1300 (Thirteen Hundred) Lac over the last 5 (Five) years in Government/Semi-Government/ Autonomous Organization of Bangladesh. (d) The minimum amount of free fund (liquid assets) i.e working capitals or credit facilities of the Tenderer shall be Tk 250.00 (Two Hundred Fifty) lac . Document of Liquid Assets submitted along with the tender must be issued in between publication date and submission date of the tender. Certificate of unconditional Liquid Asset must be Submit letter of commitment of Bank for line of credit to the Tenderer in favor of the work in the form PW3-7, otherwise the tender will be summarily rejected.
