
	(b)	Having Experience in successful completion of at least 1(one) number of Building Construction Work including civil, sanitary and internal electrification works amounting Tk 950.00 (Nine hundred fifty) Lac in a single of tender in Government / Semi Government / Autonomous Organization of Bangladesh during the last 05(Five) years (Years counting backward from the date of publication of IFT in the news paper). The work certificate for successful completion of a building construction work shall have to be issued by the authority concerned/Executive Engineer of concerned department / organization duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done. 
