Building Construction work with Foundation including Civil, Sanitary & Electrification work amounting to TK.240.00 [Two Hundred Forty] Lacs during last 5(five) years in a Single contract in Govt./Semi-Govt/Autonomous organization of Bangladesh, years counting backward from the date of publication of IFT in the newspaper. In case of work done under PWD the certifying authority shall be the concerned Executive Engineer. In case of work done any Govt./Semi-Govt/Autonomous organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the duly verified by the Concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done.
