The specific objective would be, but not necessarily be limited, to</p> <ul style="list-style-type: none"> • Carry out a feasibility study and identify a suitable position for the Plant with the project premise. • Carry out detailed design (architectural, structural and mechanical) and subsequently prepare estimates and bidding documents for selection of contractor for the STP. • Supervise the construction works in accordance with the General and Particular conditions of Contract, the Technical Specification, Engineering Drawings or any amendments thereto; • Provide necessary suggestion to optimize the use of available material resources to minimize costs or to maximize the quality of the works or to expedite construction; and • Ensure that works are constructed within contract price and time for completion allowed under the contract or any agreed amendment thereto. <p>The total period for completion of the above-mentioned services is Six (6) months and the various activities and deliverables shall be phased efficiently over that period.
