(C) The required average annual construction turnover shall be greater than Tk [ 60(Sixty) Lac] over the last [5(Five)] years

(D) The minimum amount of Liquid Assets i.e. working capital or credit Line(s) of the tenderer shall be Tk. 30 ( Thirty ) Lac only, supported by Bank certificate. Bank statement should be counted 28 (Twenty Eight) days before

from the date of opening of tender.
