(C) The required average annual construction turnover shall be greater than Tk [400(Four hundred ) Lac] over the last [5(Five)] years

(D) The minimum amount of Liquid Assets i.e. working capital or credit Line(s) of the tenderer shall be TK. 120(One hundred twenty) Lac only, supported by Bank certificate. Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.
