(c) The required average annual construction turnover shall be greater than Tk 115.40 Lakh over the last 5(Five) years in Government/Semi-Government/ Autonomous Organization of Bangladesh supported by payment certificates. (d) The minimum amount of free fund (liquid assets) i.e working capitals or credit facilities of the Tenderer shall be Tk 64.00 Lakh.
