(D) The minimum amount of Liquid Assets i.e. working capital or credit Line(s) of the tenderer shall be TK. 100.00(One hundred) Lac supported by Bank certificate. Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.

(E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate

(F) Up-to dated ABC category contractory & Supervisory License issued from Electrical licensing Board, Government of Bangladesh.
