(d) The minimum amount of liquide assets or working capital or credit facilites of the tenderer shall be TK.12.00(Twelve) lacs in the form of PW2a-3 which in attached in Tender Document, mentioning the name of work, supported by Bank certificate (Original copy only). Bank statement period should be counted 28(Twenty eight) days before submission of tender to be attached. In case of credifacility conditional certificate shall not be accepted(conditions such as subject to approval from head offices as per banking norms or subject to completion of bank's required formalities etc).
