Having experience in successfully completion/execution of at least 1(one) number of RCC building works including Civil, Sanitary AND Electrification works worth not less than Tk. 120.00 (One hundred and twenty) Lakh] only in a single work order in Government/ Semi Government/Autonomous Organization of Bangladesh during last 5(five) years.
- 3.The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk.150.00 (one Hundred and fifty) Lakh.
- 4.The minimum amount of Liquid Assets i.e. working capital/credit facilities/creditline of the tenderer shall be TK. 65.00 (SIXTY FIVE) Lakh only, supported by Bank certificate against the name of the work in the form of PW2a-3 (Line of Credit) only. Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.
- 5.Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate
6. Up-to dated ABC category contractory & Supervisory License issued from Electrical licensing Board, Government of Bangladesh.
