- (c) The required average annual construction turnover shall be greater than Tk 315 (Three Hundred Fifteen) Lac over the last 5(Five) years in Government/Semi-Government/ Autonomous Organization of Bangladesh.
- (d) The minimum amount of free fund (liquid assets) i.e working capitals or credit facilities of the Tenderer shall be Tk 80 (Eighty) Lac. Document of Liquid Assets must be issued in between publication date and submission date of the tender.
