(c) The tenderers shall have a minimum average annual construction turnover during last 5(five) years of Tk. 3,00,000.00 (Three Lakhs). Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.

(d) The minimum amount of credit facilities of the tenderer shall be Tk. 5,00000.00 (Five Lakhs). Document submitted along with the tender must be issued in between publication date and submission date of the tender. Letter of Commitment for Bank's undertaking for Line of Credit as per form PW2a-3 of Tender and Contract Forms section must be submitted for this purpose.
