(a) The minimum number of years of General Experience of the tenderer in the construction works as Prime Contractor or Sub-contractor or Management Contractor Shall be 10 (Ten) years.

(b) The minimum experience as a prime Contractor or Subcontractor or Management Contractor in successful completion of at least 1 (one) number of minimum 2 (Two) storied R.C.C. Building construction works with minimum 4 (Four) storied foundation including civil, internal sanitary and internal electrification works of Tk.150.00 (One Hundred and Fifty) Lac in a single contract within last 5(five) years in any Government / Semi-Government / Autonomous organization of Bangladesh.

(c) The tenderers shall have a minimum average annual construction turnover during last 5 (five) financial years of Tk. 400.00 (Four Hundred) Lac. Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of construction turnover.

(d) The minimum amount of credit line(s) of the Tenderers shall be Tk. 100.00 (One Hundred) Lac in the form PW2a-3 (Failing to submit in PW2a-3 will make the tenderer non-responsive). Document submitted along with the tender must be issued in between publication date and submission date of the tender.

(e) The minimum tender capacity shall be Tk.160.00 (One Hundred and Sixty) Lac.To Calculate Tender Capacity, the Tenderer must be submitted list of on-going works under any public sector and existing commitment must be mentioned.

(f) Tenderer's having quoted the tender price more than 10 (Ten) percent above or below the official estimated cost, shall be rejected.
