(d) The minimum amount of credit line(s) of the Tenderers shall be Tk. 5 (Five) crore in the form PW3-7 (Failing to submit in PW3-7 will make the tenderer non-responsive). Document submitted along with the tender must be issued in between publication date and submission date of the tender.
