- C) The required average annual construction turnover shall be greater than Tk [1000.00(One thousand) Lac] over the last [5(Five)] years
- D) The minimum amount of Liquid Assets or working capital or credit Line(s) of the tenderer shall be TK. 200.00(Two hundred) Lac supported by Bank certificate. Bank statement should be counted 28(Twenty Eight) days before from the date of opening of tender.
- E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate
- F) Up-to dated ABC category contractory & Supervisory License issued from Electrical licensing Board, Government of Bangladesh.
- G) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.
