(A) Reputed Government approved contractors/construction firms who have minimum 05 (Five) years of general experience in Construction works.

(B) Having experience in successfully completion/execution of at least 1(one) number similar nature of construction work worth not less than Tk. 120.00 (One Hundred and Twenty) Lakh in a single work order/tender in Government/ Semi Government/Autonomous Organization of Bangladesh during last 5(five) years in standard work completion format attached in STD.

(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 400.00 (Four Hundred) Lakh.

(D) The minimum amount of Liquid Assets i.e. working capital/creditline of the tenderer shall be Tk. 200.00 (Two Hundred) Lakh only, supported by Bank certificate against the name of the work in the form of PW2a-5 (Line of Credit). Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.

(E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate

(F) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.
