(C) The required average annual construction turnover shall be greater than Tk [110(One hundred ten ) Lac] over the last [5(Five)] years

(D) The minimum amount of Liquid Assets i.e. working capital or credit Line(s) of the tenderer shall be TK. 70 (Seventy ) Lac only, supported by Bank certificate. Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.

(E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate

(F) Up-to dated ABC category contractory & Supervisory License issued from Electrical licensing Board, Government of Bangladesh.

(G) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.
