(B) Having experience in successfully completion/execution of

i) At least 1(one) number of Conference System and On grid solar PV system works worth not less than Tk. Thirteen (13) Lakh only and ii) electrical works worth not less than Tk. four (4) Lakh only in a single work order in Government/ Semi Government/Autonomous Organization of Bangladesh during last 5(five) years.

(C) The Tenderer shall have a minimum average annual construction turnover during last 5 (five) years amounting of Tk. Thirty (30) Lakh.

(D) The minimum amount of Liquid Assets/working capital/credit facilities/creditline of the tenderer shall be TK. Seventeen (17) Lakh only, supported by Bank certificate against the name of the work. Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.
