 - (c) The required average annual construction turnover shall be greater than Tk.350.00 (Three Hundred Fifty) Lac over the last 5(Five) years in Government/Semi-Government/ Autonomous Organization of Bangladesh.
 - (d) The minimum amount of free fund (liquid assets) i.e working capitals or credit facilities of the Tenderer shall be Tk.90.00 (Ninety) Lac. Document of Liquid Assets submitted along with the tender must be issued in between publication date and submission date of the tender.
