 - ii) The minimum specific experience as a Contractor in construction works of at least 1(one) contract of similar nature RCC building construction work successfully completed in Government / Semi-Government / Autonomous organization of Bangladesh within the last 05 (five) years, with a value of at least Tk. 140.00 (One hundred forty) lakh
 - iii) The required average annual construction turnover shall be greater than Tk 300.00 (Three hundred) lakh in the last 5 (Five) years.
 - iv) The minimum amount of liquid asset i.e working capital or credit line(s) of the Tenderers shall be Tk 90.00 (Ninety) lakh (adequacy of minimum liquid assets i.e working capital substantiated by any scheduled Bank of Bangladesh in the format (without alteration or addition) as specified Form PW 2a-3 (CPTU STD PW2a) (Failing to submit in PW2a-3 will make the tender non-responsive).
 - v) The minimum Tender capacity shall be: Tk 160.00 (One hundred sixty) lakh only.
