Mir/Pik/WD3 and of Tk.44(forty four) crore for package no. Mir/Pik/WD4 in a single contract in Government/ Semi-Government/ Autonomous Organization of Bangladesh during last 10(ten) years. In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer. In case of the work done under any Government/ Semi-Government/ Autonomous Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done. Prescribed form for work certificate for this purpose will be available in all offices mentioned in clause no.09.</p> <p>(c) The tenderers shall have a minimum average annual construction turnover during last 5(five) financial years of Tk. 35.00(thirty five) crore for package no.Mir/Pik/WD3 and of Tk. 45.00(Forty five) crore for package no.Mir/Pik/WD4. Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.</p> <p>(d) The minimum amount of liquid asset or working capital or credit facilities of the tenderer shall be Tk.8(eight) crore for package no. Mir/Pik/WD3 and of Tk.10(Ten) crore for package no.Mir/Pik/WD4. Document submitted along with the tender must be issued in between publication date and submission date of the tender. Letter of Commitment for Bank's Undertaking for Line of Credit as per form PW3-7 of Tender and Contract Forms section must be submitted for this purpose.</p>
