 - c) The required average annual construction turn over must be greater than Tk.100.00 (One Hundred) Lakh only during last 5(five) years. Necessary supporting documents shall be submitted with the tender. Any estimated cost or contract value will not be considered to calculate Average Annual Construction Turnover. (time will be counted backward from the date of publication of IFT in e-GP system)
 - d) The tenderer must have a minimum amount of free funds (liquid Assets) /Credit facilities, working capital Tk. 75.00 (Seventy five) Lakh only.
 - e) Having updated VAT, IT, Trade License , ABC/BC/C Electrical license & supervisory license.
