		b) Having experience in successful completion of at least 1(one) number of similar nature of Electrical Solar pannel works worth not less than for lot No.01 Tk 10.00 (Ten) Lac only and others Lot of similar nature of Electrical works worth not less than for Lot No.02 Tk 6.00 (Six) Lac only, Lot No.03 Tk 2.00 (Two) Lac only and Lot No.04 Tk 2.00 (Two) Lac only in a single work order in Government / Semi-Government/ Autonomous Bodies/ Organization of Bangladesh during last 5(five) years.(Time will be counted backward from the date of publication of IFT in the newspaper). Any estimated value or contract value or work done value will not be allowed to consider successful completion of Electrical works in a single tender.
		c) The required average annual construction turn over must be greater than for lot No.01 Tk 10.00 (Ten) Lac only, Lot No.02 Tk 6.00 (Six) Lac only, Lot No.03 Tk 2.00 (Two) Lac only and Lot No.04 Tk 2.00 (Two) Lac only during last 5(five) years. Any estimated cost or contract value or work done value will not be Considered to calculate Average Annual Construction Turnover for each Package.(Time will be counted backward from the date of publication of IFT in the newspaper). It will be also in payment certificate with payment amount.
		d) The tenderder must have a minimum amount of free funds (liquid Assets) /Credit facilities, working capital for lot No.01 Tk 10.00 (Ten) Lac only, Lot No.02 Tk 6.00 (Six) Lac only, Lot No.03 Tk 2.00 (Two) Lac only and Lot No.04 Tk 2.00 (Two) Lac only as stated in tender data sheet of tender document.Bank statement of certificate in support of liquid assets, working capital or credit facilities issued from the Bank on the date not before 28(twenty eight) days from the date of tender submission would be considered for evaluation. In case of credit facilities, it will be in the form of PW2a-3. (For each Package). Any form of liquid asset's 'original copy' must be submitted with the tender.
		e) Having upto date ABC/BC/C Electric license & Supervising License by issuing Authorized electric Licensing board.
		f) Other required eligibility and conditions of the tenderer are shown in tender data sheet of the tender documents.
		g) VAT, IT & Trade license etc. shall have to be up to date.
		h) All condition will be furnished according to PPR-2008 and with all amendments.
