- Eligibility of Tenderer :**
1. The minimum number of years of General Experience of the tenderer in the construction works as Prime Contractor or Sub-contractor or Management Contractor Shall be 10 (Ten) years.
 2. The minimum specific experience as a Prime Contractor or Subcontractor or Management Contractor in RCC Construction works of at least 1 (one) number contract of 08- storied building with 03(three) basement and 08- storied mat/pile foundation successfully completed within the last 5 (Five) years with a value of at least Tk. 25.00 (Twenty Five) crore in Govt./Semi-Govt./Autonomous organization.
 3. The tenderers shall have a minimum average annual construction turnover during last 5 (five) financial years of Tk. 30.00(Thirty) crore. Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.
 4. The minimum amount of liquid asset or working capital or credit facilities as PW3-7 format of the tenderer shall be Tk. 07.00 (Seven) crore. Document submitted along with the tender must be issued in between tender publication and submission date
 5. The minimum tender capacity shall be Tk. 30.00(Thirty) crore. To calculate minimum tender capacity the tenderer must be submitted list of contract agreement, up to date payment certificate for on-going and completed contract under any public sector for the year in which maximum value of works performed within 5 years. In case of JV, Agreement between leading and other partner shall be required.
 6. The Tenderer must possess up-to-date trade license, ABC License, VAT Registration, Tax certificate & 3(three) sets of steel shutter.
